TIEF Study Abroad Program Development Grant (\$6,000)

The Texas International Education Fund will award up to nine institutions with a multi-year study abroad program development grant. During year one of the award, the grants will support faculty and staff members in their development of new faculty-directed programs. The grant may cover expenses associated with:

- Travel expenses related to a site visit.
- Professional development opportunities with direct relevance to creating and sustaining a new study abroad program and measuring impact.

In addition, during year two, funds will be used to lower the student cost during its first year of operation. The Senior International Officer (or designated representative of international programs for the institution) will propose one faculty-led program from their institution to be considered for this grant. The total amount of the two-year grant will not exceed \$6,000. A maximum of \$4,000 will be allotted for travel expenses to a site visit or professional development opportunity. At least \$2,000 must be directed to lower overall student cost of the proposed study abroad program. Selected institutions will decide whether they would accept the funds as a direct donation, grant or gift (all funds for this grant will be provided in the form of a check from TIEC).

The application deadline for this grant is May 6th, 2024.

TIEC reserves the right to deny items in the budget that they deem as an improper use of funds.

Preference:

While TIEF is interested in supporting the development of all new faculty-directed programs, proposals that include the following will receive priority:

- Proposals that include a sustainability plan, such as including more than one faculty or staff member, methods for measuring impact, and support of leadership to continue the program after the expiration of the grant period.
- Proposals from academic units that will provide additional funds during either year 1 or 2 of the grant.
- Proposals that are expanding opportunities on existing programs.
- Proposals that include a strong connection to two or more of the United Nations Sustainable Development Goals, the details of which can be found here. https://sdgs.un.org/goals
- Proposals for the development of programs for institutions/academic areas/colleges that do not currently have a faculty-directed program.

Eligibility

- Faculty-led program must be 2 weeks or longer.
- Faculty-led program must operate during year two, at a minimum.

Evaluation:

- **Impact of Proposal** Will this proposed program increase the study abroad opportunities for students within your institution? Will a good number of students be involved in this program, in contrast to only a few? Is there a strong probability of program implementation and/or continuity if this proposal is funded? Is there evidence of positive departmental support for the proposed program?
- **Quality of Proposal** Does the proposal articulate a well-thought-out plan for developing a study abroad program/course? Does the proposal contain creative ideas with a credible, appropriate, and attainable approach? Is the budget complete and realistic?

Requirements of Award:

- Recipients must initiate the timeline/show initial objectives met within the first twelve months.
- Successful recipients are expected to provide a summary (up to 4 pages) of project outcomes and any proposed next steps within one month of completion.
- Recipient bios and project summaries will be featured on the TIEC website.
- TIEC believes in creating space for members to share achievements among their peers. As such, recipients agree to present their programs and outcomes for a TIEC-organized webinar or Operating Council meeting.

TIEF Study Abroad Program Development Grant Evaluation Rubric

The following rubric is intended to provide a continuum of ratings that will guide the evaluation of TIEF Grant proposals. The rubric is intended as a guide for the assignment of a composite rating to each proposal on a scale of 0-10.

Proposed program Overview:

- 10 Compelling and convincing articulation of the potential study abroad program. The proposed program is clearly described and well thought out. The course objectives are realistic, and the proposed program contains a variety of creative activities/field excursions that connect back to the objectives of the course. There is a clear description of why the proposed program will be an attractive and relevant offering for students.
- **5** Acceptable articulation of the potential study abroad program. The course objectives are feasible, but the description lacks details. There is no clear explanation of why the proposed program would be an attractive offering for students.
- **0** Poor articulation of the potential study abroad proposed program. The description is not clear, the objectives are unattainable.

Alignment with University's Internationalization Goals:

- **10** Compelling and convincing articulation of how the proposed program clearly connects to the university's strategic internationalization goals. There is a clear description of how the proposed program will greatly improve their internationalization efforts and drive growth.
- **5** Acceptable articulation of the proposed program. The proposed program lacks details on how it connects to the university's strategic internationalization goals. The description does not clearly state how the proposed program will greatly improve their internationalization efforts and drive growth.
- **0** Poor articulation of the proposed project. There are no details on how the proposed program connects to their university's internationalization agenda.

Alignment with UN Sustainable Development Goals:

- 10 Aligns completely with two or more of the UN's Sustainable Development Goals.
- 5 Partially aligns with the UN's Sustainable Development Goals.
- **0** Does not align with any of the UN's Sustainable Development Goals.

Sustainability Plan:

- 10 The sustainability plan for the proposed program is clearly described. There is a compelling articulation of how the proposed program will continue beyond the grant. The recruitment strategy is well thought out and the program is positioned to be offered on a consistent basis.
- **5** The sustainability plan for the proposed program is clearly described but is not compelling and is lacking details on how it will be offered on a consistent basis.
- **0** The program isn't sustainable based on the explanation.

Use of Funds:

- 10 The budget narrative clearly connects the use of funds with the goals of the proposed program. The budget narrative explains how all of the funds from the grant will be used to develop the proposed program.
- **5** The budget narrative is clear but is lacking details on how all the line items connect with the goals of the proposed program.
- **0** The budget narrative is poorly written and does not contain details on how funds will be utilized.
